**NOTICE INVITING e-AUCTION SALE – MLD/Nle-A-01/2020 Dt. 15-10-2020, OF THE OFFICE OF THE  
DISTRICT MAGISTRATE, MALDA**

Sealed bids are hereby invited on "AS IS AND WHERE IS BASIS" by the District Magistrate, Malda from bonafide bidders for Auction sale of below described vehicles declared as unclaimed property and lying at Malda Collectotarate Premises.

All concerned are requested to view to the website <http://eauction.gov.in> for this auction.

Terms and conditions of Auction Sale:

1. The property is being sold on "As is where is", "As is what is", and "Whatever there is " basis.
2. The intending bidders/firms should possess valid up to date copy of a) Income tax returns b) Professional Tax Clearance Certificate c) GST Registration d) latest Trade licence and upload online self attested scanned copies of all documents as indicated in the web site, otherwise no approval will be given. The original documents (for verification only) with a photocopy of each will have to be submitted to the office of the District Magistrate, Malda by the highest bidder before issue of lifting order.
3. Intending bidders shall hold a valid email address and should register their mail/ account by login to the website <https://eauction.gov.in/>
4. 'STARTING PRICE' as indicated in the e-auction notification published, may not be considered as the 'BASE PRICE' for the items. Base price for the lot has been fixed by the competent authority and the same has been kept confidential. The highest bidder will be considered on the basis of the reserve price fixed by competent authority and not on the basis of the starting price.
5. Earnest Money: Rs. 20,000.00 (Rupees twenty thousand only) for the items will have to be submitted in the form of DEMAND DRAFT only in favor of the DISTRICT MAGISTRATE, MALDA from any nationalized bank, self attested and scanned copy of which has to be uploaded online at the time of 'DOCUMENT SUBMISSION/PAYMENT START DATE' i.e. 10/11/2020, 11.00 Hrs. After opening of the bids, earnest money of all intending bidders except highest bidder (H1) & Second highest bidder (H2) will be refunded, after due sanction is obtained from the competent authority. However earnest money of the second highest bidder (H2) will be refunded only after the acceptance of lifting order by H1. The earnest money deposited by H1 will be refunded only after satisfactory completion of work certificate is furnished by the officer(s) in charge and also after completion of all formalities and clearance by the competent authority. No bid will be accepted without the earnest money. The original bank drafts will have to be submitted at the office of the District Magistrate, Malda on or before 23/11/2020, 15.00 Hrs., otherwise the on line bids will not be accepted by this office.

6. 100% bid amount as decided by the agency (Highest Bidder, H1), will have to be deposited by the agency/firm before collection of goods and as directed by competent authority, failing which earnest money shall stand forfeited to the Government and the bidder shall be debarred from participating in any auction under the District Magistrate, Malda for a minimum period of one year and may be blacklisted if deemed fit by the Competent Authority.
7. It is urged upon the intending bidders to provide their credentials and office details properly and clearly in the space provided for the same – online and offline, as it may lead to confusion and may invite rejection.
8. Auction materials, as mentioned, will have to be collected from the Malda Collectorate Premises, at the purchaser's own arrangement (viz. vehicles and manpower for loading). No expenses in any form towards disposal will be borne by the office/ Department. The items can be viewed between 12.00 Hrs to 16.00 Hrs on any working day with the permission of the District Magistrate, Malda and in the presence of official representatives only. Bids may be placed after physical verification of the listed auction materials only.
9. Road challan for disposal will be provided by the District Magistrate, Malda. However all other permits/permissions required for transportation and disposal will have to be arranged by the Bidder. Disposal of the dismantled materials/goods have to be arrange as per relevant disposal rules and traffic rules of the area. All such type of incidental costs will have to be considered by the bidders while quoting their bid/offer. The successful bidder at his own cost has to adopt all safety/preventive/precautionary measures following relevant rules of the Government for safe disposal of all materials or spare parts. Permission from appropriate authority if needed for such process has to be procured from the end of the bidder at his own cost. This office will in no way be responsible for any issues or disputes arising out of the above.
10. In general the highest bid will be accepted. However, the bid inviting authority shall not be bound to accept the highest bid and can go for subsequent calls, if the highest bid in the option of the undersigned does not appear to be satisfactory, the undersigned reserves the right to hold fresh bid and so on without assigning any reasons what so ever. Otherwise, the bid inviting authority will issue lifting order to the successful bidder whose rates stand highest for the lot of press and allied materials mentioned.
11. Bids placed by the agency (H1) will be accepted as per terms and conditions laid down vide Govt. of West Bengal, Finance department order no. 4068-F(Y) Dt. 25-05-15.
12. If the materials or spare parts are required to be dismantled for removal, all precautionary measures will be taken by the auctioneer, so that no damage to any government property or personnel takes places. Under no circumstances, dismantling measures, which can cause a fire hazard, will be permitted. Any damage or loss of Government/public/private property or life during the lifting/dismantling process, will be the sole responsibility of the successful bidder and the successful bidder has to replenish the cost of such damage at his own cost as per estimate prepared by concerned office, failing which the earnest money of the bidder will be forfeited and necessary departmental/legal action may be initiated.
13. The dates and times published online are final and no request for any change will be entertained under any circumstances. Moreover, no objection in any form shall be entertained after completion of online scrutiny of documents.


14. All auctioned materials have to be removed from the site within 4 (Four) days from the date of issuance of lifting orders, or as directed by Competent Authority, failing which the earnest money will be forfeited without issuing any further notice and the lifting order may stand cancelled.
15. It shall be deemed that all bidders have thoroughly read and understood the terms and conditions of sale before bidding. It will also be deemed that all the bidders have inspected the items prior to auction and have satisfied themselves with the full particulars of the same. No objection or claim of any nature whatever shall be entertained at the conclusion of the auction. The online bids may be submitted accordingly.
16. The purchaser shall assume all liability for, and keep the District Magistrate, Malda saved, harmless and indemnified against all actions or suits, claims, costs, damages, charges and expenses arising out of or in connection with the fulfilment of the terms and conditions of the sale, whether such actions, suits, or claims are brought by members of the public or workmen employed, provided, however, that he will not have to indemnify the District Magistrate, Malda and the District Magistrate, Malda for any action that may be brought by a claimant and who may question the legal right of Govt. to dispose off the property.
17. Failure on the part of any bidder to observe and abide by any or all the above noted terms & conditions will disqualify himself to become eligible bidder and his earnest money or part thereof as necessary may stand forfeited to the Government.
19. The auction inviting authority reserves the right to accept or reject any or all of the bids without assigning any reason thereof.
21. Highest bidder will be accepted on grand total basis of all the listed items (one lot).
22. The undersigned will have the final decision, in case of any dispute.
23. All legal issues, if any arising out of the above auction will be limited to Malda Jurisdiction only.
25. The E – auction advertisement does not constitute and will not be deemed to constitute any commitment or any representation by this office. The authorized Officer shall not be responsible in any way for any third party claims/rights/dues.
26. In case of default in payment at any stage by the successful bidder/ auction purchaser within the stipulated time, the sale will be cancelled and the amount already paid will be forfeited and the property will be again put to sale.
