In cancellation of this office Notice Inviting Tender No.1899/N dated 15.06.2021 fresh Sealed Tender on prescribed format are invited for installation of 100 KVA Silent Diesel Generator set with Acoustic Enclosures with complete AMF Panel at Old Circuit House, Malda under District Magistrate, Malda on monthly hire basis preferably from the resourceful Electrical Contractors/Agencies/ Suppliers. Sealed Tender on plain paper/printed letterhead would have to be deposited in the box kept in chamber of the Nezarath Deputy Collector, Malda.

The following terms and condition is to be given as mentioned below at the time of submitting Tender

1. No conditional Tender will be entertained.
2. The Hiring Charges should be quoted on "monthly basis " including fuel consumption and wage cost for manning including GST. Quoted rate must be supported with Analysis for the same.
3. At the time of operating the DG Set supply quality to the assured line voltage 415 Volt and frequency to 50 Hz is to be maintained strictly. Necessary arrangement may be made to show the voltage and frequency openly.
4. The DG set operators should have good experienced at least minimum 01(one) year and sound knowledge for operation and maintenance of Generator and control panel.
5. The Generator Set is to be installed at the cost of the successful tender within the stipulated time at site so fixed up by the District Magistrate, Malda.
6. The Operation and maintenance of the DG set will be the tender's responsibility and its running cost would also to borne by the render.
7. The intending tenders should submit their offers in format along with refundable amount Rs.10000/-(Rupees Ten thousand) only as earnest money in form of Bank Draft in favour of the District Magistrate, Malda.
8. Intending tenders have to submit valid up-to-date PAN, PT, IT, GST clearance and or Registration certificate and Trade Licence along with the tender paper.
The service of the DG Set to provided for 24(twenty four) hours on all days including Saturday, Sunday and Holidays.
9. Credential (if any) for similar nature supply should be submitted along with the tender papers, which will be regarded as an added advantage.
10. The successful tender will have to execute an agreement of Terms & Conditions the details of which be fixed later on.
11. Acceptance of lower rate is not obligatory.
12. The accepted tender may get the necessary order for running the DG set installation for a period of 03(Three) years as the same terms & conditions subject to fulfillment of relevant norms.


