B) Representative of the District Magistrate C) FEO/FFA of the concerned Block or representative of the Assistant Director of Fisheries. Malda. D) GP Prodhan or his/her authorized representative. E) Concerned beneficiary/Beneficiaries.

The specification & quantity of fish seed to be supplied as above have been indicated in the approved scheme. In this regard the following points to be ensured.

1. The Deshi Magur (*Clarious batracus*) seeds should be live, good quality & healthy.
2. The items should have to be delivered at the convenient sites in consultation with the FEO/FFA of concerned Development Blocks.
3. After completion of supply of mentioned items the Bills in duplicate should be submitted duly certified by the FEO concerned Dev. Block / representative of the Assistant Director of Fisheries, Malda
4. Supply should be completed by 30 days from date of receipt of supply order, work should be started with in shortly from the receipt of the letter.
5. 8% security will be deducted from the Bill & rest 2% will be adjusted from earnest money out of 10% security money by the DDO which will be refunded after 180 days.
6. Pictorial documents of distribution of the same has to be submitted after distribution programme positively.
7. As per availability of fund the payment will be made by the DDO on recommendation of the implementing authority.
8. Distribution programme will be made maintaining social distance.
