SPECIAL TERMS & CONDITIONS :

- 1) The rate so quoted invariable be inclusive of all taxes, Cess, levy, royalties, carriage, loading, unloading etc. including incidental charges thereof and the rate should be valid till completion of the work.
- 2) If any Tenderer offer abnormally lower rate than the schedule rate, he will have to clarify regarding his offered rate at the time of opening of Tender.
- 3) Before submission of the Tender, the contractor must visit the work site to judge the local condition from all corners and no plea / complain about the site will be entertained afterwards. It will be presumed that the agency offered the Tender rate after review of entire position of the work site

- 4) Time is essence of contract. The successful contractor must complete the work within the limit specified for completion. No extension of time will be allowed.
- 5) No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
- 6) The successful Tenderer will have to abide by the provision of West Bengal Contract Labour Rules, 1972 as will be forced from time to time. If no labour license is obtained and produced by the contractor, payment is liable to get withheld.
- 7) All the works are to be executed according to drawing and specification approved by the authority and the direction of o/c infrastructure cell is to be strictly followed.
- 8) The successful Tenderer will have to start the work after execution of the Formal agreement as per rule and will have to complete the work within the time allowed for completion.
- 9) Incomplete tender will be rejected summarily. The successful Tenderer will have to execute a formal agreement on a Non-judicial stamp paper worth **Rs. 10/- (ten) within 10 (ten) days** from the date of issue of work order.
