In partial modification of Order No. 18/JM/XIII-32/2020 dated 10/01/2022, the following points have been corrected micro Containment Zone Serial no. 4 in Ward No. 8 Mokdumpur is substituted by Mission Ghat (Mokdumpur) and point no. 5 stand Cancelled

WHEREAS, as per Order No.753/XVI-ISS/2M-22/2020 dated 02.01.2022 of the Chief Secretary to the Govt. of West Bengal, local areas and pockets of high incidents of Covid-19 cases may be declared as Micro Containment Zones.

AND

WHEREAS, the Sub-Divisional Officers have informed the necessity to notify this specific locations for containment.

Now, therefore, in exercise of the power conferred upon the undersigned under section 34 read with section 26 of the Disaster Management Act 2005 and Vide clause -1 of the order of Chief Secretary as mentioned above, the following areas of Malda District are hereby notified as Micro Containment Zones

- *1. Intensive surveillance mechanism shall remain in place within the zone specified as above.
- *2. There shall be no movement of population/vehicle in or out of the zone except for medical emergencies and for maintaining essential goods and services.
- *3. No person within the zone specified shall come out of their houses without valid reason and without informing the appropriate authority .
- *4. No business activity/ individual construction work is allowed within the zones being notified.
- *5. Packaged food-grains(as per entitlement) shall be transported from the ration shops to the individual household falling within the zone by appropriate designated team /teams arranged by concerned officers.
- *6. Mask wearing is to be strictly followed along with other Covid appropriate behaviour.
- *7. Health authorities are to keep a strict vigil in these areas & ensure quick admission of patient with serious symptoms.

This shall remain in force until further order.


